#### 1. JURISDICTION

This event is a ClubSport Basic Event promoted by MotorSport Bay of Plenty Inc at Te Matai Motorsport, TECT Park, Pyes Pa.

The Meeting will be held under these Supplementary Regulations, the MotorSport NZ National Sporting Code and its Appendices and Schedules particularly Schedule C, Part One, Appendix Five, Schedule C being the Standing Regulations for all ClubSport Events and Schedule C, Part Two, Appendix Five, pertaining to Motorkhana's and Schedule A, Appendix Two – Driver and Vehicle Safety Requirements.

#### 3. EVENT DESCRIPTION:

##### 3.1

Gravel Surface Motorkhana held at the Hub Site at TMMI and Gravel Surface Autocross on the Autocross Track.

The Upper Crust Bakery Junior Motorkhana Championship is running again this year. Competitors between the ages of 12 and 18 have free entry and are in the running for a Winner's Trophy and Certificates for placings at each Round, with the Overall winner at the end of the series presented with a stunning trophy and a certificate for free entry into the National ClubSport Championships.

**Classes:** Vehicles will be divided into the following classes.

A	0-1600cc
B	1601-2000
C	2001-3500cc
D	3501 and over
E1	4WD pre year 2000
E2	4WD year 2000 and over

**4. ENTRIES:**

**4.1** Registration of Interest/Entries is available through the MotorSport Online system

The Club prefers that entries are made online; however, entries will be accepted on the day up to the close of Documentation for the Motorkhana at 1:45pm and up to the close of Documentation for the Autocross at 5:00pm.

Organisers reserve the right to refuse any entry in accordance with the prescribed provisions of the National Sporting Code.

**4.2 Opening and Closing Dates:**

Entries open with the publication of these regulations and close at the end of Documentation, 13:45pm for the Motorkhana and 1700 for the Autocross, on the day of the Event. **Entries will be accepted on the day.**

**4.4 ELIGIBLE VEHICLES**

**Compliance:** All vehicles shall comply with Appendix Five Schedule C and Appendix Two Schedule A of the current MotorSport Manual unless stated otherwise in these supplementary regulations.

**Vehicles:** No Rally, Mud or Snow Tyres.

All vehicles shall as a minimum be to a warrantable standard, with a securely mounted seat, safe steering and effective brakes.

The Clerk of the Course has discretionary powers as to the type of vehicle deemed suitable for the venue.

**5. COMPETITOR REQUIREMENTS and UNDERSTANDING:**

**5.1 Licence Requirements:**

All drivers must hold a current club membership of a member club except for new entrants to motorsport, who may compete in two (2) Basic Status Events before being required to join a club.

The licence requirements are as follows:

(1) Basic Status Events: A competition licence is not required.

(a) Junior Competitors: Any competitor between the ages 12-16 years who does not hold a valid MotorSport NZ competition licence may be allowed to compete in Basic Status Events on the following conditions;

(i) That the venue restrictions along with the vehicle type and cubic capacity restrictions detailed in Appendix One Schedule L Part One Article 3.2(2) are respected, and

(ii) Only at the discretion of the Event Clerk of the Course.

## 5.2 Competitor Understanding:

In submitting the entry competitors (Entrant and Drivers) are deemed to fully understand the MotorSport NZ National Sporting Code and its relevant Appendices and Schedules. In particular:

- The National Sporting Code Articles pertaining to protests and competitors' obligations, and
- Appendix Five, Schedule C.

5.3 All competitors shall wear safety apparel in compliance with Appendix Two, Schedule A.

**Motorkhana** – There are no requirements to wear Safety Apparel other than **closed toed shoes**.

**Autocross** – This is a Clubsport Basic Event. Clothing requirements are as follows:

- Helmet
- Overalls – Minimum of Cotton Overalls
- No Fireproof Underwear or socks required
- **Minimum of leather shoes**
- No gloves required
